

LUCKY DRIVE TO AUSTRALIA TERMS & CONDITIONS

1. Terms and conditions applicable to the #VisitKIA “Lucky Drive to Australia” Competition (“Competition”) conducted by KIA Motors South Africa (Pty) Ltd (“Promoter”).
2. The Competition will run from 1 November to 30th November 2018. Entries received after the closing date will not be considered.

WHO CAN ENTER

1. Participants must be 18 years or older, have a valid driver’s license, have a valid identity document, a valid passport that does not expire before July 2019, be a South African citizen or a permanent resident of the Republic of South Africa and reside in the Republic of South Africa during the period of the Competition up until the redemption of the prize (“Participants”/”you”/”your”).
2. Participants wishing to enter must register on www.visitkia.co.za, and must take a test drive in any KIA vehicle at an Official KIA Dealership. The Competition will be held at all Official KIA Dealerships between 1st November 2018 and 30th November 2018.
3. Only 1 (one) entry per person will only go into 1 (one) main lucky draw, except for entrants who purchase the KIA vehicle subsequent to the Test Drive, who will receive 2 (two) entries into the main lucky draw.
4. Entries must be by the participant and not by a third party on the participant’s behalf.

HOW TO ENTER

1. Participants are to register their details and book a test drive of any KIA vehicle, from 1 November 2018 to 30th November 2018, on www.visitkia.co.za. The selected KIA Dealership will contact the participant to confirm the test drive.
2. The winner will be determined at the end of the Competition period and will be selected by a random draw overseen by an independent party in terms of the Consumer Protection Act 68 of 2008.
3. The winner will be announced on Tuesday 4th December 2018, after the close of the Competition. The winner will be contacted via telephone or e-mail on the phone number and/or e-mail address registered on www.visitkia.co.za, and as confirmed with the KIA Dealer Salesperson at the time of a test drive.
4. KIA Motors South Africa will make 3 (three) attempts to contact and notify the selected winner. If the selected winner cannot be contacted personally after 3 (three) attempts, or if after first being contacted by the Promoter, is not reachable, or the winner fails to provide the Promoter with the required information to hand over the prize, the winner will forfeit the prize and a replacement winner will be selected from the names drawn from remaining qualifying participants. This process shall continue until the winner has been contacted and the prize has been awarded in terms of the Competition rules.

5. KIA Motors South Africa (Pty) Ltd will facilitate all travel arrangements.

PRIZE

1. Participants can enter and stand a chance to win 1 (one) return flight in economy class for 2 (two) people (one winner plus one partner) to Australia, from Johannesburg, South Africa, including travel insurance, a pre- determined, 4-day and 3-night full hospitality program, hosted by KIA Motors Corporation, accommodation for two people (in one room), meals, transportation in Australia, as well as tickets to the 2019 Australian Open .
2. The prize does not cover any other cost of the winner whatsoever, specifically any visas that may be needed, spending money and any expenses that fall outside the official KIA Motors Corporation Hospitality Package.
3. The prize is only valid for travel during the 2019 Australian Open.
4. Winners must be able to travel between Saturday 14th and 29th January 2019

CONSUMER PROTECTION AND DATA PRIVACY

1. Nothing in these terms and conditions is intended to, or must be understood to, unlawfully restrict, limit or avoid any rights or obligations, as the case may be, created for either the Participant or the Promoter in terms of the Consumer Protection Act.
2. By entering, a Participant acknowledges that personal information about the Participant will be shared with the Promoter and KIA Dealerships to the extent necessary to conduct the Competition and for the prize to be delivered to prize winner.
3. All personal information relating to the Participants will be used solely in accordance with South African consumer and data protection legislation.
4. By entering this competition and winning, the winner (and to whom they give the second ticket too) may be required to participate in marketing or promotional activities that include social media postings.

GENERAL

1. The Promoter of this competition is KIA Motors South Africa (Pty) Ltd, registration number 1968/003273/07.
2. Participants may not enter or receive a prize if they are directors, members, partners, employees, agents of or consultants of the Promoter and their subsidiaries, holding companies, divisions and/or associated companies or of the advertising or promotion agencies or any other person who directly or indirectly controls or is controlled by KIA Motors South Africa, or their spouses, life partners, immediate family members or business partners.
3. By entering this Competition, all Participants agree to be bound by these terms and conditions, and the Promoters decision regarding any issue with the Competition will be final and binding and no correspondence will be entered into.
4. Incomplete or incorrect entries will not be eligible to be entered into the draw. The Promoter and KIA Dealerships within their sole discretion will determine whether the Participant did a test drive or not based on the pre-announced entry mechanics, as promoted online and in all KIA Dealerships.
5. The prize is not transferable or negotiable and may not be exchanged for cash. The Promoter reserves the right to substitute the prize for an alternative

prize of equal or greater value should the prize promoted not be available due to unforeseen circumstances.

6. The Promoter and KIA Dealerships will not be liable for any loss suffered as a result of incomplete or incorrect information provided.

The Promoter reserves the right to select an alternative winner in the event that they reasonably believe, in their sole discretion, that the winner is not eligible to win, has contravened any of these terms and conditions, has acted in a manner that is not in the spirit of the Competition, their conduct can be reasonably interpreted as scamming or circumventing the rules of the Competition, acted fraudulently with regards to the Competition, if it would be unlawful to award the prize or if the winner fails to accept the prize after 3 (three) attempts for any reason whatsoever, if after first being contacted by the Promoter, is not reachable, or the winner fails to provide the Promoter with the required information to hand over the prize. In this instance the winner will be disqualified and forfeit the prize. The Promoters decision shall be final and no correspondence will be entered into.

When claiming the prize, the Promoter reserves the right to request the winner to provide to the Promoter with positive identification (including a valid identity document and passport) and proof of driver's license valid during the period of the Competition, failing which they may be disqualified and forfeit the prize.

Please note that the following terms require you to take on risk or liability, limit the risk and liability of the Promoter or to indemnify the Promoter. 11. To the fullest extent permitted by law, by participating, the Participant indemnifies, releases and agrees to hold harmless the Promoter, their associated, holding and subsidiary companies, and its directors, officers, agents, representatives,

shareholders, employees, successors and assigns from any and all claims or liability arising from participating in the Competition, any Competition-related activity and/or acceptance, receipt, possession or use/misuse of the prize.

12. To the extent permitted by law, the Promoter will not be liable for any defects in the prize or any losses caused by such defects or losses arising from incorrect or inaccurate information supplied by Participants.

13. The laws of the Republic of South Africa shall govern these competition terms and conditions and the courts of South Africa shall have exclusive jurisdiction.
